You can include together with this form a **candidate statement of no more than 100 words** to be published together with the ballot. The candidate's name and the position sought will not be counted in those 100 words. In addition, and so voters can learn more about you, you can also submit a **short bio with bulleted information** (e.g.: years of experience in education, worksite(s) assigned to, union involvement, current and past work/career assignments, etc.), **plus a good quality color photograph**, of only yourself. Bios and photos may be cropped/reduced in size to fit voting material. Candidate statements, bios and photographs that are timely submitted will be published with the ballots.

IT IS THE RESPONSIBILITY OF THE CANDIDATE TO ENSURE THAT THE REQUIRED FORMS ARE COMPLETED AND RECEIVED AT THE TRUE OFFICE BY THE DUE DATE AND TIME.

CAMPAIGNING RULES FOR TRUE ELECTIONS

1. SITE LIST:

Each candidate shall have the right to a list of the names and addresses of work sites and the number of Active members at each site, for the purposes of campaigning. Request of that list must be made in writing and e-mailed to true.office@yahoo.com or sent through regular mail to the TRUE office: 3318 Howard Street, Suite 10, McClellan, CA 95652.

2. TRUE PUBLICATIONS:

TRUE may not endorse a candidate for any position. TRUE may not state or indicate its preference for a candidate in the unit's publications.

3. CAMPAIGN CONTRIBUTIONS:

- a. Monies received by TRUE by ways of dues, assessment or similar levy must not be applied to promote a candidate.
- b. Candidates may not accept direct contributions from TRUE's treasury or indirect contributions in the form of use of TRUE's assets, facilities, staff, equipment, mailings, good will and credit.

4. LOGO:

The use of any and all TRUE/CTA/NEA logos shall not be allowed on campaign materials. The official Association title may not be used in any way that suggests that the candidate has the support of TRUE, CTA and/or NEA or their affiliates.

5. CAMPAIGN FLYERS/MATERIALS:

All campaign flyers/materials must include the following disclaimer, which must be stated verbatim: "The views and opinions expressed are those of the candidate and not necessarily those of TRUE, CTA and/or NEA."

6. District e-mail addresses and/or electronic systems shall not be used for campaigning for TRUE elections. Use of district school mailboxes for campaigning must follow district policy.

7. All privileges extended by TRUE to one candidate must be extended to all candidates.
